Call to Order: 8:07 PM

REFEREE LIASION: No Report (Not Present)

OLD BUSINESS: Rep from the Reading Phillies was present to discuss a fundraising opportunity with club reps. Information was handed out to each to take back to their clubs. Referee mentor program will begin in April after Easter. Fleetwood will be hosting their annual tournament May 14-16. There are some teams that have so many secondary players that the team cannot be approved. We need to address this issue and come up with a solution. Every district except Reading Berks has a cap on secondary players. U11-U15 need 9 primary, U16-U19 need 11 primary and U9&U10 as well as U11&12 8v8 need 7 primary to approve team.

Motion to limit secondary players for 8v8 to 4 and U11-U15 to 5 per team: 1st: Amity 2nd: Gov. Mifflin
Motion to change U14 from T2(one referee system) to T1(3 referee system) for Spring season: 1st: Mt Penn 2nd: Exeter All present voted in favor.

NEW BUSINESS: The Muhlenberg 7v7 tournament will be held in June. Fleetwood Tournament will be May 14-16 and the registration deadline has been extended to the 30 of April. They currently have 53 teams and take about 25 more. Amity will host its 3v3 tournament on June 12. Wyomissing Quarry Classic will be held May 7, 8 and 9. Gov. Mifflin brought up the fact that with moving teams around for relegation there have been a lot of blow out games. He made the suggestion that clubs mention to their coaches to try to be respectful to the other team and not run scores up.

A vote on the motion to limit secondary players for 8v8 to 4 and U11-U15 to 5 per team was done via show of hands. All clubs present voted in favor with the exception of Muhlenberg, Kutztown, and Tulpehocken.
